

Regulation 18 and 19 Consultations Wigan Council

1. Introduction

- 1.1 The role of Wigan's Statement of Community Involvement (SCI) is to set out how the council intends to engage with local communities, businesses and other interested parties when developing and reviewing planning documents and determining planning applications.
- 1.2 This Compliance Statement demonstrates that consultation has been undertaken in accordance with the approved Wigan SCI at each stage of the Greater Manchester Spatial Framework / Places for Everyone Plan preparation process. The Council consulted bodies, organisations and individuals in accordance with the SCI, using a broad range of methods to advertise the consultations. A range of evidence is illustrated in the appendices.

2. Background

- 2.1 Public consultation on the Greater Manchester Spatial Framework (GMSF) under Regulation 18 of the Town and Country Planning (Local Planning) (England) Regulations 2012 took place in 2016 and 2019 in accordance with Wigan Council's 2015 SCI.
- 2.2 The SCI was updated in 2020 ahead of scheduled consultation on the publication draft of the GMSF. However, this plan was not taken forward following the withdrawal of Stockport Council from the plan process, and the GMSF was replaced by the Places for Everyone (PfE) Plan. The 2020 SCI referred to the GMSF, so was updated in 2021 to refer to the PfE Plan and to update references to COVID-19 restrictions. Public consultation on the PfE Plan took place in accordance with the Council's 2021 SCI, which can be viewed at: Statement of Community Involvement (July 2021) (wigan.gov.uk)

- 3. Consultation undertaken at the Draft and Revised Draft GMSF stages Regulation 18 Consultation
- 3.1 In accordance with Regulation 18 of the Town and Country Planning (Local Planning) (England) Regulations 2012, the Draft GMSF was published for public consultation from 31 October 2016 to 23 December 2016 and the Revised Draft was published for public consultation from 21 January 2019 to 18 March 2019.
- 3.2 A wide range of methods were used to raise awareness about the consultations and to encourage people to respond. The publicity methods aimed to target the full range of stakeholders.
- 3.3 The 2015 SCI set out that we would involve the following stakeholders:
 - **Specific consultation bodies** these are organisations specified by law for consultation as appropriate, including those responsible for services, utilities and infrastructure provision, Parish Councils in and adjacent to the borough, adjoining councils and Government departments.
 - **General consultation bodies** these are community and voluntary bodies with an interest in the borough and bodies that represent different racial, ethnic, national or religious groups, disabled persons or persons carrying on business in the borough.
 - Elected representatives this includes local councillors, Members of Parliament and Members of the European Parliament
 - **The general public** this includes people who live in, work in or visit the borough or have another interest in the borough.
 - **Businesses** those with business interests in the borough.
 - Landowners, developers and agents those who have a direct interest in future development and have a major role to play in providing the facilities and services the borough needs.
 - Duty to co-operate prescribed bodies these include neighbouring councils and other prescribed bodies as set out in law, many of whom are also specific consultation bodies.
- 3.4 The 2015 SCI also set out **how** we would involve these stakeholders. It stated that:
 - We would contact appropriate organisations and individuals directly by email, or by post when it is the only means available

- We would publicise consultations by methods such as our website and other websites as appropriate, press releases, local newspapers and radio, social media, site notices, meetings, workshops and 'drop-in' sessions.
- We would make consultation documents available on our website; on other websites if appropriate; at Wigan Library, which is part of the Wigan Life Centre, the Wiend, Wigan, our principal office for visiting members of public; and at other public libraries.
- We would publish comments received, or a summary of them, as soon as possible and explain how they have been taken into account in preparing the plan.
- 3.5 The SCI did not commit the Council to all the methods of publicity for every consultation. It set out a list of options, to be selected as and when appropriate for each consultation.
- 3.6 Further detail is set out in the following sections about the stakeholders engaged and how we engaged them as part of the consultation process for the Draft GMSF (2016) and the Revised Draft GMSF (2019).

Draft GMSF 2016

Emails / Letters

- 3.7 Emails or letters regarding the Draft GMSF were sent out to:
 - All general and specific consultees
 - All elected representatives
 - Members of the general public and businesses included on the Council's Local Plan consultation database
 - Landowners, developers and agents with an interest in the plan and / or its proposed allocations
 - The Duty to Cooperate prescribed bodies as identified in Part 2 of the Town and Country Planning (Local Planning) (England) Regulations 2012.
- 3.8 Emails were used where an email address was known, and letters sent to consultees where an email address had not been provided. The emails / letters informed people of the consultation, gave a brief overview of the content of the Draft GMSF, directed people to the consultation documents via the Wigan Council or Greater Manchester Combined Authority (GMCA) websites and provided details about how to make comments. Information was also provided about the proposed public drop-in sessions that were being held in venues across the Borough. Telephone contact details were provided for the Greater Manchester Planning Team and the planning policy team at Wigan Council, if people required any further general, or site specific, information.
- 3.9 Elected members were also provided with briefings about the consultation.

3.10 A copy of the general email sent is found in Appendix 1A, a copy of the general letter in Appendix 1B and a copy of the elected member email in Appendix 1C.

Website

3.11 All consultation documents were made available on the GMCA website and a link to this was provided on Wigan Council's GMSF webpage, which also provided additional Wigan specific information. The GMCA website provided details about how to respond to the consultation. The primary method for providing views was through use of an online consultation portal (Objective Keystone), but details were also provided to enable responses by email, or by post. Wigan Council's web text can be found in Appendix 1D.

Press Release / Local Newspapers

3.12 An article on the Draft GMSF consultation was published in the Wigan Evening Post on 2 November 2016. This can be found in Appendix 1E.

Social Media

3.13 The Draft GMSF was publicised on social media (Twitter and Facebook) during the consultation period. Social media publicising the consultation and the drop-in sessions can be found in Appendix 1F.

Site Notices

3.14 Site notices were put up in multiple locations in the vicinity of the 10 sites that were proposed for allocation in the Draft GMSF, informing local people of the consultation and the proposed allocations. An example site notice is included in Appendix 1G

Meetings / Workshops / Drop-in Sessions

3.15 A series of drop-in sessions were held in seven locations around Wigan Borough where the public were invited to attend to discuss the Draft GMSF with Wigan planners. Table 1 provides details of these drop-in events.

3.16 The drop-in sessions were publicised via a variety of means including social media (Twitter), the written press (Wigan Observer and Wigan Evening Post), site notices, the Wigan Council webpage and in the consultation emails / letters. In total they were attended by 418 people.

Libraries

3.17 Paper copies of the Draft GMSF were made available for the public to view at all public libraries within the borough. The libraries also provide free public internet access, which provided a facility for the public to access the Draft GMSF consultation online.

Revised Draft GMSF 2019

Emails / Letters

- 3.18 Emails or letters regarding the Revised Draft GMSF were sent out to:
 - All general and specific consultees
 - All elected representatives
 - Members of the general public and businesses included on the Council's Local Plan consultation database, including those who had commented at the Draft GMSF stage, unless they did not wish to be informed of future GMSF stages.
 - Landowners, developers and agents with an interest in the plan and / or its proposed allocations
 - The Duty to Cooperate prescribed bodies as identified in Part 2 of the Town and Country Planning (Local Planning) (England) Regulations 2012.

- 3.19 Emails were used where an email address was known, and letters sent to consultees where an email address had not been provided. The emails / letters informed people of the consultation, gave a brief overview of the content of the Revised Draft GMSF, directed people to the consultation documents via the GMCA website and provided information about how to make comments.
- 3.20 Consultees were also directed to information on the Wigan Council website GMSF page, which provided information about proposed public drop-in sessions that were being held in venues across the Borough. A copy of the general email sent is found in Appendix 2A.

Website

3.21 All consultation documents and evidence base documents were made available on the GMCA website and a link to this was provided on Wigan Council's GMSF webpage, which also provided additional Wigan specific information. The GMCA website provided details about how to respond to the consultation. The primary method for providing views was through use of an online consultation portal (Objective Keystone), but details were also provided to enable responses by email, or by post.

Press Release / Local Newspapers

3.22 An article on the Revised Draft GMSF consultation was published in the Wigan Post on 21 February 2019. This can be found in Appendix 2B.

Social Media

3.23 The Revised Draft GMSF was regularly publicised on social media (Twitter and Facebook) during the consultation period. Screenshots of a tweet and a Facebook newsfeed update publicising the drop-in sessions can be found in Appendix 2C.

Meetings / Workshops / Drop-in Sessions

- 3.24 Elected members were given briefings about the Revised Draft GMSF on 14 January 2019 in Leigh and on 15 January in Wigan. The briefings covered:
 - The overall strategy
 - Housing requirements and land supply
 - Economic development
 - Proposed site allocations
 - Green Belt
 - Transport
 - Environment
 - Consultation and next steps
- 3.25 A series of drop-in sessions were held in five locations around Wigan Borough where the public were invited to attend to discuss the Revised Draft GMSF with Wigan planners. Locations were selected that were near to the five major

sites that were proposed for allocation in the 2019 GMSF. Table 2 below provides details of these drop-in events.

3.26 The drop-in sessions were publicised via a variety of means including social media (Twitter and Facebook), the Wigan Council webpage and the consultation emails / letters. In total they were attended by 235 people.

Libraries

- 3.27 Hard copies of the Revised Draft GMSF and associated documents were made available for the public to view at all public libraries within the borough. Paper copies of the following documents were deposited in each library:
 - Greater Manchester's Plan for Homes, Jobs and the Environment (the Revised Draft GMSF)
 - Integrated Appraisal of the GMSF (2 documents)
 - GM Transport Strategy 2040: Draft Delivery Plan
 - GM Transport Strategy 2040: Draft Delivery Plan Executive Summary
- 3.28 The libraries also provide free public internet access, which provided a facility for the public to access the Revised Draft GMSF consultation online.

- 4. Consultation undertaken at the Places for Everyone-Publication stage Regulation 19 Consultation
- 4.1 In accordance with Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012, the Publication version of the PfE Plan was published for public consultation from 99 August 2021 to 93 October 2021.
- 4.2 A wide range of methods were used to raise awareness about the consultations and to encourage people to respond. The publicity methods aimed to target the full range of stakeholders.
- 4.3 The Wigan 2021 SCI refers specifically to the PfE Plan and highlights that consultation on it is carried out on a joint basis in line with the Town and Country Planning (Local Planning) (England) Regulations 2012 and the nine GM districts' SCIs.
- 4.4 The 2021 SCI reflects the uncertainty and constraints imposed by the Covid-19 pandemic. It states that where circumstances arise that are beyond our control such as the Covid-19 pandemic, we may not be able to utilise all forms of consultation and engagement listed in the document in a socially distanced manner. In such circumstances we will tailor consultations in line with legal requirements and up-to-date government guidance.
- 4.5 Wigan's 2021 SCI states that we will involve the same stakeholders as set out in the 2015 SCI, with the exception of Members of the European Parliament, as the United Kingdom is no longer in the European Union.
- 4.6 The 2021 SCI sets out **how** we will involve these stakeholders. It states that:
 - We will contact appropriate organisations and individuals as set out in the 'Who? section directly by email, or by post when it is the only means available.
 - We will publicise consultations by methods such as our website, and other websites as appropriate, and our social media, and by press releases, local newspapers and radio, Borough Life magazine and site notices, as appropriate.
 - We will organise meetings, workshops and drop-in sessions where appropriate. However, the SCI notes that where circumstances arise that are beyond the council's control such as during the Covid-19 pandemic or other times of social distancing the council may not be able to make use of some of the methods listed. In such circumstances consultation methods will be tailored in line with legal requirements and up-to-date government guidance.

- We will utilise forms of online engagement methods at different stages of plan preparation, such as virtual exhibitions, digital consultations, video conferencing, as appropriate.
- We will make consultation documents available on our website, and on other websites were appropriate.
- We will make hardcopy versions of consultation documents available at the Wigan Life Centre, The Wiend, Wigan, which is our principal office for visiting members of public, specifically in Wigan Library within that building; together with other public libraries.
- We will publish comments received, or a summary of them, as soon as possible and explain how they have been taken into account in preparing the plan. The exception to this is at the formal 'publication' or 'proposed submission' stage of the plan, after which representations are passed to the independent inspector to consider at the public examination, and following the examination when the inspector recommends proposed modifications to the plan which need to be consulted upon.
- All public buildings used for consultation purposes will be accessible and meet wheelchair access regulations.
- 4.7 The SCI does not commit the Council to all the methods of publicity for every consultation. It sets out a list of options, to be selected as and when appropriate for each consultation.
- 4.8 Further detail is set out in the following sections about the stakeholders engaged and how we engaged them as part of the consultation process for the Publication stage of the PfE Plan.

Emails / Letters

- 4.9 Emails or letters regarding the PfE Plan were sent out to:
 - All general and specific consultees
 - All elected representatives
 - Members of the general public and businesses included on the Council's Local Plan consultation database, including those who had previously responded to a consultation on the joint development plan, or had asked to be kept informed of its progress.
 - Landowners, developers and agents with an interest in the plan and / or its proposed allocations.
 - The Duty to Cooperate prescribed bodies as identified in Part 2 of the Town and Country Planning (Local Planning) (England) Regulations 2012.
- 4.10 Emails were sent where an email address was known, and letters sent to consultees if an email address had not been provided. The emails / letters informed people of the consultation, directed people to the plan and

supporting documents on the GMCA website and provided information about how to make comments. In addition, consultees were also directed to the dedicated Places for Everyone webpage on Wigan Council's website where further information was provided. A copy of the general email sent out can be found in Appendix 3A and the elected member email in Appendix 3B. The web text on the Council's Places for Everyone webpage is in Appendix 3E.

- 4.11 The emails / letters included a Statement of Representation Procedure Notice that explained the procedure for making representations and what happens next, including how to participate in the Examination. The notice set out that responses could be submitted using the online response form, by email and by post. The notice can be found in Appendix 3D.
- 4.12 Bespoke emails / letters were also sent out to residents, landowners or occupiers of land north of Mosley Common (Appendix 3C).

Website

4.13 All consultation documents and evidence base documents were made available on the GMCA website and a link to this was provided on Wigan Council's PfE webpage, which provided additional Wigan specific information, including on the four site allocations proposed in the borough. The primary method for providing views was through use of an online consultation portal (Objective Keystone), but details were also provided to enable responses by email, or by post.

Social Media

4.14 The PfE Plan was regularly publicised by Wigan Council on social media (Twitter and Facebook) during the consultation period. Screenshots of tweets and Facebook newsfeed updates from Wigan Council publicising the plan can be found in Appendix 3F.

Press Release / Local Newspapers / Borough Life

4.15 The PfE Plan consultation was publicised in the Wigan Evening Post, Wigan Today and the Leigh Journal (Leaders Column), as evidenced in Appendix 3G. It also featured in My Wigan Borough Updates (Appendix 3H), which are regular electronic updates about what is happening across the borough that people can subscribe to.

Site Notices

4.16 Site notices were put up in multiple locations in the vicinity of the four major sites that were proposed for allocation in the PfE Plan, informing local people of the consultation and the proposed site allocations. The site notices and their locations can be found in Appendix 3I. Site Notices were also sent to relevant ward councillors for display in community noticeboards. Notices were also put up to advertise 6 proposed Green Belt additions (Appendix 3J).

Meetings / Workshops / Drop-in Sessions

4.17 Taking account of the position in terms of Covid–19 and in accordance with the 2021 SCI no drop-in sessions or workshops were held.

Online Engagement Methods

4.18 The GMCA website hosted a virtual exhibition site for the duration of the PfE consultation. It provided links to the PfE Plan, the consultation material and the online consultation portal. The space also included videos relating to the consultation, a map for each district showing key information including site allocations, a link to frequently asked questions, a link to supporting / background documents and a link to archived GMSF material.

Libraries

- 4.19 Copies of the PfE Plan were not deposited at all borough libraries due to the impact of Covid-19. However, paper copies of the PfE Plan were deposited at the borough's largest and most accessible libraries in Wigan and Leigh for the public to view.
- 4.20 The libraries also provide free public internet access, which provided a facility for the public to access the PfE Plan consultation online.





Almost one in five disabled workers have had a job offer withdrawn because of their health condition.

Research by disability charity Leonard Cheshire suggested most disabled people were frozen out of work.
A survey of, 500 disabled dults found three in four had stopped work because of a disability or health issue. Almost one in five who had applied for a job in the past five years said the employer withdraw the offer as a result

of their disability. A separate poll of 500 managers showed two-thirds believed the cost of making workplace adjustments were a barrier to employing a disabled person.

Leonard Cheshire boss Neil Heslop said: "Our research reveals at lough and unwelcoming employment landscape for disabled people, despite overall employment. I levels climbing to record highs. Most disabled people in 2019 remain frozen out of the world of work.

A brief explanation of the background of this document and its relationship to other development plan documents being produced by the relevant nine Greater Manchester districts is provided below.

Background

In 2014, the ten Greater Manchester local authorities agreed to prepare a joint Development Plan Document, the Greater Manchester Spatial Framework (GMSF), with the GMCA co-ordinating its production on behalf of the ten districts. In December 2020, Stockport Council took the decision to withdraw from the GMSF. Subsequently, the nine remaining authorities (Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Trafford, Tameside and Wigan), agreed to continue to progress a joint Development Plan Document for themselves, known as Places for Everyone, which will form part of their individual district local plans.

PfE2021 provides the strategic policy framework for the districts including the overall scale and distribution of development, the spatial strategy, strategic site allocations and Green Belt boundary amendments together with a number of strategic thematic policies which will be used to manage development and determine planning applications in the individual districts. PfE2021 is accompanied by a Policies Map which shows the allocations and designations in the Plan.

Documents available for inspection

PfE2021 and supporting/background evidence documents are published on the GMCA Website on behalf of the nine districts. Additionally, copies of PfE2021 documentation will be made available in accordance with the Town and Country Planning (Local Planning) (England) Regulations 2012 and the requirements of each district's Statement of Community Involvement (SCI). In Wigan, a hard copy of the PfE 2021 Plan is available at Wigan Library and Leigh Library.

Places for Everyone Plan

The Council is working in partnership with the Greater Manchester Combined Authority and eight other Greater Manchester districts (Bolton, Bury, Manchester, Oldham, Rochdale, Salford, Tameside, and Trafford) to prepare a joint development plan called Places for Everyone.

Proposed site allocation: M6 Junction 25, Wigan

Land at M6 Junction 25 is proposed to be allocated for around 140,000 square metres of employment floorspace, as part of the Places for Everyone Plan.

Planning permission for employment development was granted on this site in July 2021. Delivery in accordance with this planning approval is not dependent on the site's allocation in the Places for Everyone Plan. Its allocation in the plan will remove the site from the Green Belt.

Proposed site allocation: North of Mosley Common

Land North of Mosley Common is proposed to be allocated for around 1,100 homes as part of the Places for Everyone Plan.

The development would be required to provide good quality road access into the site including from Mort Lane, Bridgewater Road and Silk Mill Street with choices of connection across the site.

This site significantly benefits from the Leigh-Salford-Manchester Guided Busway which crosses the site providing direct and sustainable rapid public transport access to employment, leisure and retail services within Manchester City Centre and other places along its route. The development would be required to provide an additional busway stop and/or provide improved pedestrian and cycling links to existing stops, and contribute effectively to increased passenger capacity on the busway as appropriate.

The development will also be required to provide new community, health and education facilities on-site, or an equivalent financial contribution as appropriate, to meet additional demand generated by the new homes.

Proposed site allocation: Pocket Nook, Lowton

Land at Pocket Nook is proposed to be allocated for around 600 homes and 15,000 square metres of employment floorspace on land currently safeguarded for future development in the adopted development plan. The site is not within the Green Belt.

The site would be principally served from a new junction on the A579 Atherleigh Way, close to its junction with the A580. The development would be required to deliver a new road from Atherleigh Way through the site to Newton Road and would need to bridge the proposed HS2 route, which runs north-south through the west of the site. This road would serve both new housing and employment development and would be able to accommodate bus services.

There is potential to enhance sustainable travel opportunities by foot, cycle and public transport in the Lowton and Golborne area for employment and other services in Leigh and the Regional Centre, consequently reducing car dependency in this area; and, with possible connections to Leigh Guided Busway services. It is also important that safe and convenient pedestrian access is provided to green spaces within and adjacent to the site.

Proposed site allocation: West of Gibfield

Land West of Gibfield is proposed to be allocated for around 500 homes and 45,500 square metres of employment floorspace as part of the Places for Everyone Plan.

The development will be required to make highway improvement measures at the junction of the A577 and Gibfield Park Way, extend Gibfield Park Way northwards and contribute effectively towards the provision of appropriate highway mitigation measures to provide enhanced access to/from the A6 and Junction 5 of the M61. This includes safeguarding land within the allocation so as not to jeopardise the potential future delivery of a strategic link road connecting Gibfield Park Way to the A6 and M61.

The employment development would be delivered in the south east of the allocation as a logical extension to the existing employment area at Gibfield Park. It is envisaged that this will consist predominantly of light industrial uses, with the potential of creating in the region of 500-1,000 new jobs.


The scheme would also provide a substantive accessible green corridor and country park on land to the west of the development, on land which would remain in the Green Belt, providing wildlife habitats and recreational space for existing and future residents to enjoy. The country park will help to offset ecological harm and enable the achievement of at least a 10% biodiversity net gain, as well as improving access from the site to Daisy Hill railway station by walking and cycling.




Appendix 3I: 2021 Places for Everyone Consultation – Site Notice Locations M6 J25




