

# Regulation 18 and 19 consultation and SCI Compliance Statement: Salford City Council

### Introduction

1.1 This Statement meets Regulation 22 (1)(c) (i) and (ii) the Town and Country Planning (Local Planning) (England) Regulations 2012 and demonstrates that the consultation has been undertaken in accordance with relevant Regulations and Salford's adopted Statement of Community Involvement (SCI). The Council have consulted bodies, organisations and individuals in accordance with their SCI, using a broad range of methods to advertise the consultation. A full range of evidence is illustrated in the attached appendices.

### Background

- 2.1 When work commenced on the Greater Manchester Spatial Framework (GMSF), Salford City Council was also preparing its own local plan and had recently completed its Suggested Sites Consultation. As the GMSF was set to identify the overall long-term planning strategy for the whole of Greater Manchester (including identifying the housing and employment land requirements for each of the Greater Manchester authorities), it was considered appropriate by Salford City Council to run all future stages of the GMSF and the Local Plan in parallel. As a result, Salford went out for public consultation on its Draft and Revised Draft Local Plans at the same time as the public consultation for the Draft and the Revised Draft GMSF (2016 and 2019 respectively). Reference was therefore made to both consultations, in all publicity that the city council undertook in 2016 and 2019.
- 2.2 For both the Draft GMSF consultation in 2016 and the Revised Draft GMSF consultation in 2019, the same approach was taken to consultation. This is outlined below.
- 2.3 At this time, Salford's adopted Statement of Community Involvement (SCI) (January 2010) and set out how and when the community would be involved in the preparation of planning documents and the determination of planning applications.
- 2.4 In October 2020 Salford's SCI was partially updated to reflect changes to set out the city council's approach to engaging with the public in the production of formal planning documents and also planning applications, during the Covid-19 pandemic (or similar).

## Consultation undertaken at the Draft and Revised Draft GMSF stages – Regulation 18 consultation

- 3.1 In accordance with Regulation 18 of the Town and Country Planning (Local Planning) (England) Regulations 2012, the Draft GMSF was published for consultation on 31 October 2016 and representations were invited until 23 December 2016.
- 3.2 The Revised Draft GMSF was published for consultation from 21 January 2019 to 18 March 2019, with representations invited during this period.
- 3.3 All consultation documents were made available on the GMCA website and a link to this was also provided on the city council's GMSF webpage. See Appendix 1 for the city council's web text for both stages. Paper copies of the Draft GMSF and Revised Draft GMSF were made available at the Civic Centre, Swinton and also at each of the city's libraries during their normal opening hours. A paper copy of the Integrated Assessment was also available to view at the Civic Centre for both consultations.
- 3.4 Any consultee or persons wishing to make representations were invited to do so in any of the following ways during the consultation period:

### Consultees

- 3.5 The Draft GMSF and the Revised Draft GMSF letter was sent to all general and specific consultees. The list of these is set out at Appendix 2. Similarly, all of the Duty to Cooperate bodies as identified in Part 2 of the Town and Country Planning (Local Planning)(England) Regulations 2012, were consulted. These are listed at Appendix 3.
- 3.6 In addition to the above, all stakeholders on the city council's planning consultation database who had indicated an interest in the local plan were notified about the consultation and invited to submit representations (by email where provided, or alternatively by post) This included local residents, developers, planning consultants, voluntary organisations and local businesses. A total of 1,472 individuals and organisations were notified at the Draft GMSF stage, and 2,298 consultees at the Revised Draft GMSF stage.

The letters sent to stakeholders provided details of the consultations and advised how to make comments (by email where provided or by post). On both occasions the consultation letters made reference to, and provided details about, both the Draft/Revised Draft GMSF consultation and the Draft/Revised Draft Local Plan consultation. For a copy of the letter for the Draft and Revised Draft GMSF see Appendix 4.

3.7 An email was also sent to all councillors and the city council's neighbourhood managers to inform them of the consultation at the Draft and Revised Draft stages. The neighbourhood managers were asked to circulate details of the consultation across their own network of community contacts and via social media. A copy of these emails can be found in Appendix 5.

### **Consultation Event**

- 3.8 A joint consultation event for stakeholders and residents was held for the Draft and Revised Draft stages. This was held on Friday 2 December 2016 between 3 8pm for the Draft GMSF and on Monday 11 February 2019 for the Revised Draft GMSF. On both occasions it was held at the Salford Suite, Civic Centre, Swinton. The events provided an informal opportunity for stakeholders and residents to discuss both draft documents and find out more about the parts of the plan(s) which they were interested in. Planning officers from the city council and officers from Greater Manchester Combined Authority were available throughout the events to provide more information. A range of information was mounted on display boards together with copies of the respective Plans.
- 3.9 The date for the consultation event was included in the initial consultation letter sent to all stakeholders and nearer the time postings were published on both the city council's Facebook and Twitter profiles, acting as a reminder for residents. In addition, an email was sent to all neighbourhood managers asking them to cascade the details of the event down to the local community and other relevant contacts on their database. All councillors were also reminded of the event by email.

### Additional meetings

- 3.10 In addition to the drop in consultation events all of the community committees in Salford were offered the opportunity for a representative of the city council to attend their next meeting to provide details of the Plans and any relevant proposals within them for the community committee area. At these meetings a presentation was given followed by a question and answer session.
- 3.11 As part of the Draft GMSF consultation the following five community committee meetings were attended by officers:
  - Irlam and Cadishead Community Committee 17 November 2016
  - East Salford Community Committee 24 November 2016
  - Claremont & Weaste Community Committee 29 November 2016
  - Walkden Community Committee 15 December 2016

• Ordsall and Langworthy Community Committee – 10 January 2016.

At the Revised Draft GMSF consultation stage five community committee meetings were attended by officers:

- Irlam and Cadishead Stakeholder event 21 January 2019
- East Salford Community Committee 24 January 2019
- Claremont and Weaste Community Committee 29 January 2019
- Ordsall and Langworthy Community Committee 12 February 2019
- Worsley and Boothstown Stakeholder event 6 March 2019.

#### **Additional publicity**

- 3.12 The following additional activities were also undertaken to publicise the consultation periods and engage with stakeholders.
- 3.13 An article was included in the Jewish Advertiser on 13 November 2016 and the same article was published in the Jewish Telegraph on 18 November 2016 for the Draft GMSF. A copy of the article can be seen in Appendix 6.
- 3.14 An article was published in the Jewish Advertiser on Friday 1 February 2019 for the Revised Draft GMSF. The same article was made available for the Jewish Chronical, but it is understood that the opportunity to publish it was not taken up.
- 3.15 Two articles were also included on the Talking News for the Blind (a weekly audio recording of recent news items which is distributed to over 250 blind or partially sighted people across Salford), over the weekends of November 14 and December 10, 2016. An article was also included on the 1 February 2019 Talking News for the Blind for the Revised Draft GMSF. A copy of these articles can be viewed in Appendix 7.
- 3.16 Throughout the course of the consultation a series of tweets and postings were published on the city council's Twitter and Facebook profile about the consultations with some relating specifically to particular proposals of the plan, for example relation to the proposed expansion of Port Salford.

### Compliance with the Salford City Council Statement of Community Involvement (SCI) (January 2010)

- 3.17 The city council notified and invited representations from those specific and general bodies that it was considered may have an interest in the Draft and Revised Draft GMSF plans as well as the relevant Duty to Cooperate bodies and they were invited to make representations.
- 3.18 In addition to this all stakeholders on the city council's planning consultation database who had expressed an interest in one of Salford's planning documents or who had submitted representations at the earlier stage were

notified about the consultation and invited to make representations. This also included all councillors.

- 3.19 These actions above complied with paragraph 3.4 and also Figure 3.1 Development Plan Document Production process of the SCI. They also included all councillors, "hard to reach" groups and young people in accordance with paragraphs 3.26 and 3.28 of the SCI.
- 3.20 As set out above, it was considered appropriate that a similar level of publicity was undertaken at both the Draft and the Revised Draft GMSF stage in an effort to reach as many interested people as possible. All of the methods used were in accordance with the proposed methods of community engagement set out in paragraph 3.36 and Table 3.2 of the SCI.

### **Places for Everyone**

### Background

- 4.1 The Publication version of the GMSF was due to be published in December 2020 for a period of consultation, prior to submission to the Secretary of State. However, following the decision of Stockport Council not to approve the Publication GMSF Plan, it was agreed in principle at a meeting of the AGMA Executive Board on 11 December 2020 to prepare a joint Development Plan Document (DPD) for the remaining nine Greater Manchester Authorities.
- 4.2 As with the GMSF, this Joint DPD titled "Places for Everyone" principally covers strategic policies including housing and employment land requirements and, as appropriate, strategic site allocations and Green Belt boundary amendments and associated infrastructure across the nine districts.

### Consultation undertaken for Places for Everyone - Regulation 19 consultation

- 5.1 In accordance with Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations 2012, the Publication Places for Everyone was published on 9 August 2021 and representations were invited on the document until 3 October 2021.
- 5.2 A copy of Places for Everyone and all supporting documents were made available on the GMCA consultation website at <u>www.gmconsult.org</u>.

#### Internet

5.3 In Salford, a specific Places for Everyone webpage was set up with a link to the GMCA website:

- 5.4 Salford's Places for Everyone page provided a brief overview of the document and provided an update on its relationship to previous work undertaken on the Greater Manchester Spatial Framework.
- 5.5 The council webpage also referred to consultation on Places for Everyone and provided information about how to make comments. It also outlined that following the consultation, the intention was for the plan together with any comments received, to be submitted to the Secretary of State for examination in 2022.
- 5.6 Finally, the webpage also highlighted the main implications for Salford of the plan, including the 4 site allocations within the area (East of Boothstown, Hazelhurst, Port Salford Extension and Land North of Irlam Station). At the bottom of the page a list of FAQs and a copy of each of the background topic papers for each of the allocated sites in Salford was available to download.

### **Consultation Letter**

- 5.7 A consultation letter was sent to those identified as general consultation bodies and also to other consultees that were included on the city council's consultation database including individuals, organisations, developers, planning consultants, community groups and local residents and businesses who had indicated a preference to be kept informed about the local plan. This latter group were consulted to ensure consistency with the previous earlier consultations that had been undertaken for the GMSF.
- 5.8 The letter explained how the Places for Everyone plan related to the former Greater Manchester Spatial Framework and also explained how to find out more about the plan and how to make comments. A copy of the letter is provided in Appendix 8.
- 5.9 The letter was posted or emailed to those consultees where there was an email address. An email was also sent to all Salford Councillors and the Neighbourhood Managers which also included a copy of the consultation letter.
- 5.10 In addition to the consultation letter a similar letter was sent to all properties within 300m of the boundary for the four site allocations in the Places for Everyone plan. Extracts of the site allocation policy and site boundary plan were also included with these letters.

### Availability of documents

5.11 A copy of the plan, representation form and guidance notes, and also the Statement of Representation Procedure and the Statement of Inspection locations were made available at each of the city's libraries that were open, and also at the Gateway Centres throughout the course of the consultation. A copy of the Integrated Assessment was also put on deposit at Swinton Gateway as the Civic Centre in Swinton was closed at the time of the consultation due to COVID19 restrictions. Publicly accessible computers

were available at all locations for use by all consultees to access electronic versions of the plan and all supporting documents. Copies of the Statement of Representation Procedure and the Statement of Inspection Locations can be viewed in Appendix 9.

### Comments form and guidance notes

5.12 A comments form and a set of guidance notes were produced by GMCA on behalf of the 9 districts. These were published on the city council's website. Copies of the form and guidance notes were also available at each of the city's libraries and Gateway locations throughout the course of the consultation.

#### Press

- 5.13 An article on Places for Everyone was included in the August edition of Life in Salford both in the digital and paper version format. This set out the purpose of the plan and the key impacts upon Salford, and raised awareness of the consultation providing details about where further information could be found.
- 5.14 An article was submitted to the Salford Talking News for the Blind which was included in the August recording during the week commencing 30 August 2021. The article explained how the document was formerly the Greater Manchester Spatial Framework but is now known as Places for Everyone and then it set out its purpose. It highlighted the main implications for Salford including the four key site allocations within Salford and provided further information about the consultation.
- 5.15 A notice was also published in the Jewish Advertiser week commencing 16 August. See Appendix 10 for copies of the text for the Talking News, Life In Salford and Jewish Advertiser articles.

### **Site Notices**

5.16 Site notices were posted at key locations around the boundaries of the four site allocations in Places for Everyone that fell within Salford, and a site notice was also placed at each of the Green Belt addition sites. These notices raised awareness of the consultation and provided details about where further information was available. The locations where the site notices were placed for the four site allocations are shown in Appendix 11.

### **Social Media**

5.17 Throughout the course of the consultation period social media posts (Facebook and Twitter) were made by the city council to raise awareness of the consultation and also the virtual meetings held in early September.

#### **Virtual Meetings**

5.18 Salford City Council held two online events on Tuesday 14 September and Thursday 16 September 2021 to provide details about Places for Everyone, focusing on the four site allocations (North of Irlam and Port Salford on Tuesday 14 and East of Boothstown and Hazelhurst on Thursday 16 September respectively). People were asked to register for the event in advance and were offered the opportunity ask a question with the aim to address as many as possible during the event. The City Mayor, the Lead Member for Planning and council officers attended each event which commenced with a short presentation about the Places for Everyone plan with submitted questions then answered. Afterwards the events, copies of the presentations and transcripts were placed on the city council's Places for Everyone webpage.

### Compliance with the Salford City Council Statement of Community Involvement (October 2020)

5.19 Section 19 3) of the Planning and Compulsory Purchase Act (2004) requires that local authorities comply with their Statement of Community Involvement (SCI) in preparing local development documents. A copy of the adopted SCI at the time the Publication Places for Everyone plan was published can be viewed here:

- 5.20 All of the specific and general consultees and the duty to Cooperate bodies together with a wide range of individuals and organisations, including developers, planning consultants, community groups and residents and businesses who were included on Salford's consultation database, were consulted about the Publication Places for Everyone. This reflects the broad consultee groups identified in table 3.1 of the SCI. In accordance with paragraph 3.26 of the SCI, all those who had made comments at previous stages in the production of the GMSF were also notified. It also included all councillors, "hard to reach" groups and young people in accordance with paragraphs 3.27 and 3.28 of the SCI.
- 5.21 The methods of engagement used during the period for representations by Salford on Places for Everyone comprised newspaper notices, virtual meetings, pages on the Salford City Council website, letters/emails to general consultees on the consultation database, documents available for inspection, site notices, notification to councillors and the use of social media. This is consistent with the proposed methods of community engagement as detailed in table 3.2.
- 5.22 Given the importance for representations to address issues of legal compliance and soundness, GMCA produced a representation form which was made available to all districts. This was in accordance with paragraph 3.47 of the SCI. The representation forms were made available at all of the city's libraries and Gateway locations and were also made available to

download from the city council's website. Alongside this, guidance notes were provided which explained how to complete the representation form, and also explained the issues of legal compliance and soundness in more detail. This approach is considered to be consistent with the engagement methods outlined in table 3.2 of the SCI.

5.23 In accordance with paragraph 3.50 of the SCI, anyone who submitted a written representation on the Places for Everyone plan was added to the city council's database if they weren't already on it, so that they would automatically be informed of future progress of the plan's production.

### Conclusion

6.1 The approaches to both Regulation 18 and 19 consultations were in line with the Council's Statement of Community Involvement at the time and therefore met the requirements of Regulations 22 (1) (c) (i) and (ii) of the Town and Country Planning (Local Planning) (England) Regulations 2012.

### Webtext for Draft GMSF consultation

Over the next twenty years there is a need to deliver continued sustainable economic growth, creating more jobs and new homes for the people of Greater Manchester.

The ten local authorities in Greater Manchester are working together on a joint plan called the Greater Manchester Spatial Framework (GMSF) this is being prepared to ensure that new homes and jobs are provided in the right places with the transport (roads, rail, Metrolink) and infrastructure to support the communities and manage growth sustainably.

The draft Greater Manchester Spatial Framework sets out:

- How much housing and employment land is needed up to 2035.
- A number of strategic sites across Greater Manchester to assist in meeting these requirements.
- The importance of infrastructure such as, health, education, transport, green spaces and utilities to support neighbourhoods and employment.
- Ways to protect and improve the natural environment.

Public consultation on the draft version of the Greater Manchester Spatial Framework runs from **31 October to 23 December 2016**. During this time, we would welcome any comments you may have on this document and supporting background papers. Views submitted will be considered and a final draft will be published in 2017 when another period of consultation will be held.

### Webtext for Revised Draft GMSF consultation

<u>The Revised Draft Greater Manchester Spatial Framework (link to</u> <u>https://www.greatermanchester-ca.gov.uk/gmsf</u>) has been published for consultation. The closing date for making comments is Monday 18 March2019.

The Mayor of Greater Manchester and the ten local authorities in Greater Manchester are working together on Greater Manchester's Plan for Homes, Jobs and the Environment, also known as the Revised Draft Greater Manchester Spatial Framework (GMSF).

The GMSF will cover the whole of Greater Manchester and will set out how Greater Manchester should develop up to make it one of the best places to live and work in the world. It will:

- Set out how Greater Manchester should develop over the next two decades up to the year 2037;
- Identify the amount of new development that will come forward across the 10 districts in terms of housing, offices and industry and warehousing, and the main areas in which this will be focused;
- Protect the important environmental assets across the conurbation;
- Allocate sites for employment and housing outside of the urban area;
- Support the delivery of key infrastructure, such as transport and utilities;
- Define a new Green Belt boundary for Greater Manchester.

Public consultation on the Revised Draft GMSF runs from Monday **21 January to 18 March 2019** and this is an opportunity for anyone with an interest in the plan to make their views heard.

Some of the major decisions regarding Salford's future development will be taken through the GMSF, such as identifying the number of additional homes that need to be built in the city each year. All decisions about whether Green Belt boundaries in Salford should be altered, including whether any existing Green Belt should be de-designated so that it can be developed, will be made through the GMSF.

The Revised Draft GMSF proposes that the following sites in Salford be dedesignated as Green Belt and allocated for development:

- GM Allocation 30 Hazelhurst Farm (400 dwellings)
- GM Allocation 31 East of Boothstown (300 dwellings)
- GM Allocation 32 North of Irlam Station (1,600 dwellings)
- GM Allocation 33 Extension of Port Salford (320,000m<sup>2</sup> employment floorspace)

The Revised Draft GMSF is also proposing that some land in Salford is added to the Green Belt, which would result in a net increase of around 30 hectares in the amount of land in the city that is designated as Green Belt.

There will be a drop-in consultation event with officers from 3pm – 8pm on Monday 11 February 2019 at the Salford Suite, Salford Civic Centre, Swinton, to find out more about parts of the Revised Draft GMSF that you are interested in. Please note that there will be no formal presentations at this event, and you are free to join us whenever is most convenient to you between the above times. # Draft Salford Local Plan and the Draft Greater Manchester Spatial Framework

Over the next few months, public consultation will take place on two draft plans that will have significant implications for Salford's future. The Draft Greater Manchester Spatial Framework sets out the overall planning strategy for the whole of Greater Manchester, and the Draft Salford Local Plan provides more detailed policies for Salford. The most significant proposals for Salford are included in both documents.

### **Draft Salford Local Plan**

As you have previously commented on, or expressed interest in, one of Salford's planning documents we wanted to let you know that the city council has now recommenced the preparation of the Salford Local Plan, which will be the main land use planning document for the city.

The Local Plan will:

- Set out how Salford should develop up to the year 2035;

The city council reviewed the nominated sites and completed an initial assessment of their suitability for development or a protective designation. These assessments were published and consulted on between January and March 2014.

Consultation on a full Draft Local Plan is due to start on **Tuesday 8 November 2016** and run until Friday 6 January 2017 and we would welcome your views on the plan during this time.

The Draft Local Plan identifies the approach that the city council intends to take, having had regard to the comments received during the initial stages of consultation, the additional evidence that has been assembled and changes to national planning policy. A Policies Map has also been published which shows the location of sites proposed to be allocated for development or given a protective designation.

- GM Allocation 32 North of Irlam Station (1,600 dwellings)
- GM Allocation 33 Extension of Port Salford (320,000m<sup>2</sup> employment floorspace)

The Revised Draft GMSF is also proposing that some land in Salford is added to the Green Belt, which would result in a net increase of around 30 hectares in the amount of land in the city that is designated as Green Belt.



## Appendix 10

### Text for Talking News - Places for Everyone consultation

Places for Everyone is a joint planning document covering most of Greater Manchester. The areas it covers are the districts of Salford, Bolton, Bury, Manchester, Oldham, Rochdale, Tameside, Trafford and Wigan. It takes forward strategy from the 2016 and 2019 draft versions of the Greater Manchester Spatial Framework, after Stockport withdrew from that process in December 2020.

Places for Everyone will:

- Set out how the area should develop up to 2037;
- Identify the amount of new housing and employment development that will come forward and the main areas in which this will be focused;
- Allocate sites for employment and housing;
- Identify important environmental assets which will be protected and enhanced;
- Support the delivery of key infrastructure, such as transport and utilities; and
- Define a new Green Belt boundary for the nine boroughs

The plan focuses on directing development towards brownfield sites in the urban areas. In Salford the vast majority of new offices will be located in City Centre Salford and at least 85% of new housing will be on brownfield land.

However, there is not enough land in the urban area to meet housing and employment needs, which means there is an exceptional case for limited release of Green Belt land. This release of Green Belt will be kept to a minimum.

In Salford, there are four sites currently in the Green Belt that are proposed to be allocated for new built development. These are:

- Port Salford Extension: This allocation is for 320,000sqm of new employment floorspace, primarily for logistics and port related activity, with potential for advanced manufacturing. It is an area of land between the A57 Liverpool Road and the M62 motorway and will use road, rail and water (and so is trimodal) to move freight. The extension of Port Salford will significantly boost Greater Manchester's competitiveness;
- East of Boothstown: This allocation is for 300 new homes and is located to the west of RHS Bridgewater in Worsley;
- Hazelhurst Farm: This allocation is for 400 homes and is situated to the south of the East Lancashire Road and east of the M60 in Worsley; and
- Land North of Irlam Station: This allocation is for 800 new homes and is an extension to the north of the existing urban area in Irlam and Cadishead

Port Salford extension will provide a large number of new jobs for the people of Salford. Additionally, the proposed housing allocations will provide a significant number of truly affordable housing and family homes. This will help Salford residents stay in their communities and widen the range of properties that are available.

Importantly Places for Everyone also identifies additional land that should be designated as Green Belt. Overall, once the additional new Green Belt is taken into account, there would be an overall increase of 54 hectares (133 acres) of Green Belt across Salford as a result of proposals in the plan.

Consultation on Places for Everyone started on 9 August 2021. The consultation is a formal stage and comments are currently being invited until 3 October 2021. After this, the plan and all comments made on it will be submitted to the Planning Inspectorate in early 2022 for a public examination.
