GP Services in the area are over committed - What is the outcome from an impact assessment on the Sides Medical Centre from an additional (minimum) 800 new patients? Getting an appointment here is already difficult.

Congestion in the area is already awful - Worsley Road and roundabout is dangerous during rush hour. The surrounding roads on the Ringlow Park estate are already used as cut throughs and rats runs for commuters trying to get to either the East Lancs or Worsley Road or Moorside Road - some days we have to queue on our own roads to get off the estate. Although Hazelhurst Road has speed bumps this does not stop people speeding. You mention encouragement to use the guided busway - but it doesnt go anywhere near Salford quays/media city/trafford park where lots of us now work and HAVE to drive to.

Has consideration been given to putting a junction to the M60 southbound here to negate the need for people driving through worlsey village to access the motorway network?

Pollution - additional pollution from the development in the area.

Lack of green spaces already in the area - the loopline and worsley woods is used by residents of Monton, Winton, Eccles, Swinton, Ellenbrook, Walkden, Worsley and Boothstown - its crowded and impossible to navigate some times due to the volume of people, bikes, runners, dog walkers etc. The fields at Hazelhurst offer an alternative more natural walking experience.
