You would be better taking over empty properties and old buildings and retrofitting those and giving significant grants to homeowners (not benefits based as not all homeowners are cash rich) to retrofit current housing stock. The proposal does not enhance special landscapes, green infrastructure, biodiversity and geo diversity in Tameside. The number of 'affordable ' homes will only be a small small proportion of those built (GM wide). Strategic objective 3 - from other objectives the high value clusters seem to be Manchester centric or south GM centric. This links with strategic objective 4 i.e. Manchester, Quays and the airport.
