From the existing developments alone there has been a significant impact on our travel times, the public transport and doctors availability,  We REDACTED TEXT have to queue to get into and out of our estate at the peak times as cars queue upon Bridgwater road in both directions to get on the East Lancs. it can take 20 minutes just to get off our estate onto the East Lancs Road. Once on the East Lancs our problem have only just just begun as traffic queues in all directions especially towards Manchester and the M60. Our children have been placed in schools outside walking distance (Swinton) meaning we have to travel to school using these routes. A simple 10 minute drive now takes an hour both ways. There are only two routes to Swinton and indeed to Manchester being Manchester Road and East Lancs both of which regularly feature stand still traffic and yet further houses will only adversely effect that, especially on of the magnitude in this plan.  Recently they have been doing road works which have only made this worse
	and forcing us to leave even earlier,  Local Doctors are at capacity already. Waiting times are over a month and emergency appointments are very difficult to come by, my GP (Ellenbrook Medical Practice) is over subscribed and are seeking authority not to accept any new patients. They now regularly refer people to Leigh walk in centre at the hospital as they cannot offer enough appointments to meet demand. We are thankfully not in III health and don't need regular appointments however. I can only imagine those who do suffer with poor health are left.

breaking point.

## Places for Everyone Representation 2021

The attraction for this area is presumably the designated bus route between Leigh and Mosley Common where it meets the East Lancs. These busses are over capacity with people forced to stand every morning and afternoon and often people not being allowed onto buses as they are already full. Additionally people Park their cars on the streets and the local shopping area on Morston Close to catch the bus leaving no where to park for local residents to shop. Likewise on Reedley Drive and Longwall Avenue where they've had to place parking restrictions.

The local area already suffers with crime like most built up areas and our local police station cannot meet demand already. They will not be able to cope with 1100 new families. The main issues here are burglary, theft of and from motor vehicles and anti social behaviour. All of which will increase sharply with more potential victims and offenders being homed here.

In short the local infrastructure is not able to accept the added burden of 1100 new families and the drain they will place upon local over exhausted amenities and traffic network. It would be highly irresponsible to consent to this development.
