How about a local wealth tax and redistribution to the poorest 10%? Ending poverty is UN SDG number 1 and the UK is one of the most unequal developed countries in Europe. We need imaginative solutions here and I would like to see a "Citizens" Assembly on creative ways to end inequality in Greater Manchester.</p> <p>Food security will be an ever-increasing problem due to climate change. The vision does not address this adequately. Far more provision should be made for allotments and a policy of encouraging people to plant veg not lawns. The Parks and Gardens departments should be leading on this. Vertical farms and the incorporation of food production on roofs, for example, should be planned for.</p> <p>Additionally, I do not see enough being done to address the drastic loss in biodiversity and even the possible breakdown of food systems due to lack of pollinators.</p> <p>Water security and protection from flooding are also going to hugely increase in importance due to climate change. I do not see enough attention being paid to this.</p> <p>The words "enhance", "improve", "promote" in the relevant section (We will: Enhance special landscapes, green infrastructure, biodiversity and geodiversity Improve access to the natural environment and green spaces including parks Promote the role of green space in climate resilience and reducing flood risk.) are too wishywashy, given the seriousness of the existential threats we face on these fronts. The word "enhance" for biodiversity sounds like adding a frilly hem to a dress, when what is happening is that the web of life of our planet is disintegrating and this must be stopped if we are to survive.</p>

	<p>I want to see stronger language and a firm commitment to appropriate action here, e.g. "we commit to reversing biodiversity loss", "we guarantee access to the natural environment and green spaces to all social groups (unless not appropriate due to sensitivity of wildlife to intrusion) and commit to preserve all existing green spaces (by e.g. not building on them)", "we will immediately stop all building in areas susceptible to flooding and even resettle all people and businesses in those areas, in accordance with the rapidly increasing number and intensity of extreme rainfall events."</p> <p>It is also not enough to "Promote carbon neutrality of new development by 2028". What does "promote" (another wishywashy politicians" word) even mean? Ask building companies for voluntary compliance? That"s not going to work. They must be required to build carbon neutral, with carbon neutral materials etc.. Additionally, it is not enough to limit this requirement to new building. If we are to become carbon neutral quickly enough to stop our planet from careening into a fireball disaster scenario, then all existing buildings must be retrofitted to carbon neutrality by 2028. This is even more important than new build compliance.</p>
