4. Helping the Elton Reservoir country warden and monitoring wildlife on and around Elton Reservoir over 8 years I have good knowledge of the area. Which is used by Bury's residents for their wellbeing and hobbies. In places for everyone says it said it will give us a country park which is a lie as we already have one which is used by Bury's residents . The country park they want to give us is a fraction of what is already used.

Therefore the places for everyone fails and is not fit to be passed to government.

5. Elton Reservoir has the 4th largest wetland in greater Manchester and is of Biological importance and the most diverse large wetland which should be given government protection as it is home to many uk/eu protected species including, Otter,Badger, Great crested newt. This site will be destroyed by places for everyone.

Therefore the places for everyone fails and is not fit to be passed to government.

6.the consultation has been very limited with information withheld from the public into what the places for everyone actually consists off and how it will actually effect the residents of bury. For example I live in Elton ward and the information about Places for everyone failed to mention anything about any other ward. Tottington ward has a large area in the plan REDACTED TEXT and no information was given but a misleading letter advertising places for everyone plan.

Therefore the places for everyone fails and is not fit to be passed to government.

7. With regards to the clean air policy for Greater Manchester this plan places for everyone will make the air pollution worse due to building 9 thousand house on greenbelt destroying an eco system that absorbs a lot of the population giving cleaner air to breath. Also due to these houses being built the pollution would increase due to the amount of extra vehicles on the already over congested roads.

Therefore the places for everyone fails and is not fit to be passed to government.

8. The figure used are out of date inflating the number of houses required. Meaning the green belt would not be needed if the figures were upto date and correct. Therefore the places for everyone fails and is not fit to be passed to government.

9. Reading hydrocology report with regards to possible flooding. I found this to be very alarming as the report say a chance in a 100 years. Considering most fields get flooded every year I find this report untrue in its findings. As the fields flood where houses are proposed I believe they will be flooded on a regular basis.
