Please be as precise as possible.	<p>Disproportionate and excessive building in one (green belt) area of greater Manchester where people have chosen to live due to its suburban, green spaces. A large percentage of the new and affordable housing required in Greater Manchester is condensed in few locations- Mosley Common (wigan) and Ellenbrook (Salford) being two of them. This area, although contributing significantly to councils via council tax, has very few benefits in terms of leisure and transport. Transport links (A580 and motorways) cannot cope currently with the volume of traffic in the area. Nor is there a viable alternative other than a bus Lane and a train station at walkden - both with limited destinations. There is no mention in the proposals in relation to dealing with the addition cars/tragic the new housing will bring. Tragic on thd local roads are already gridlocked during rush hour and very heavily used at other times. The A580 consistently has fatal road tragic and pedestrian accidents.</p> <p>Currently, doctors appointments in thd area has waiting lists of weeks, and there are no local NHS dentists. The current green, open spaces are crucial for mental health and quality of life.</p>
