Item 6 promises "safe and convenient access for pedestrians and cyclists --- to green spaces within and adjacent to the site" but there is no mention of how this will be achieved or the nature of the spaces. How can we form an opinion without the details?

The same applies to item 7 -" Protect and enhance Carr Brook as a Green infrastructure corridor" but no detail of size or what green areas are to be linked.

The environs of Fair House Farmhouse should be informed only by the Historic Environment Assessment.

Item 18 admits that "moderate harm "would be caused to the landscape. This should be taken into consideration as it effectively removes the landscape for many residents.
