Please be as precise as possible.	<p>"Be designed to encourage the use of nearby public transport services, in particular the Leigh-Salford-Manchester bus rapid transit service, with high quality pedestrian and cycling routes and off-site pedestrian crossings that connect all parts of the site to nearby bus stops" It is not realistic that people will cycle or walk the 1 mile to the nearest bus stop for the Leigh-Salford-Manchester bus. These routes would also have to be through existing woodland or run along the already busy A580, neither ideal for pedestrians. The other nearby public transport services are not consistent, quick or cost effective enough to make public transport from this site into city centre Manchester in particular, a viable option.</p> <p>"Set aside land to accommodate additional primary school provision, unless it can be demonstrated that sufficient additional school places will be provided off-site within the local area to meet the likely demand generated by the new housing." No reference to the same provision for secondary, which will also be needed</p> <p>"Ensure that vehicular access to the site does not have an unacceptable impact on the quality of existing residential areas" This is an unachievable statement unless major changes are made, on the roads, in this area. The area is gridlocked at rush hour (pre-COVID) and the recent changes made to Worsley Roundabout have only exasperated the problem.</p>
