Exemplified by the destruction of habitat for migrating Sand Martins on the banks of the Irwell. This work seems to be required to reduce flooding in the area of the proposed Metrolink Station rather than any present need. Work already carried out in the area, for "flood protection and bank protection" of the reservoir has been done with no or little regard for the protection of other natural habitats. Bury Council have failed to give any notice of the proposals in a clear manner. A letter was sent by the Chief Executive, but this only referred to my immediate area. I have only found out that the greenbelt around Elton was at risk by way of social media. A notice was posted by Bury Council about this consultation and the impact of the proposed developments around the Elton area, but this was simply stapled to a fence using a plastic wallet, it was obviously designed not to be durable.
