Please be as precise as possible.</b></p>	<p>and farmers would not be forced to sell their family land they had farmed for 3 generations.</p> <p>Government inspector told Wigan MBC to only build 1000 houses in Lowton and Golborne and to date 1300 have been given planning permission. Government Inspector has not been listened to by the Council.</p> <p>Air pollution is in excess of national limits - even during Covid and people working from home.</p> <p>The current infrastructure is not capable of coping with the excess vehicles, not only from new builds in Lowton and Golborne but the surrounding areas using the local roads to access M6, M62 and A580 (new builds Plank Lane, Atherton, Leigh etc).</p> <p>Mayor Andy Burnham stated in 2013 that Lowton and Golborne could not take 3000 houses that Wigan planned to give planning to and the Government Inspector agreed with this.</p> <p>Years ago the Council wanted to build a MEGA SCHOOL in Lowton and close many schools including the High Schools. Local people fought this and what a mess schools would have been in now as - stated by locals the numbers of school children were going up and they have with places not available at local schools for some local children.</p>
