It's impossible to build affordable houses for 1st time buyers in a place like this. It will drive the wrong behaviour within the local housing market as they are likely to be snapped up by people who can afford more than one home and will then rent for extortionate prices.

The school situation is an even bigger problem. The local schools are over subscribed and the types of houses you're intending to build are likely to bring more young families who will in turn struggle to place their kids in schools in the area. Secondary schools is an even bigger problem.

I'm all for making areas better and more so for ensuring people can afford to live in these lovely areas - but you can't just squeeze 400 houses on a site and 'hope for the best'. Without this proposal, there is so many improvements to be made in the Worsley area, this is going to heighten those issues and put more pressure on local councils to deal with them.
