Whilst the vast majority of people appreciate there is a national housing shortage of affordable homes, there is certainly no unmet housing need in Rochdale which warrants building on this protected greenbelt land. The developers have failed to provide any exceptional circumstances for building on protected greenbelt (as they are duty bound to do) and have failed to focus on increasing housing densities on existing brownfield sites. JPA 19 is NOT about plugging the gap in any housing shortage; on the contrary, it is about profit for the developers pure and simple. That is clear from the fact that they intend to build 450 executive detached houses on this greenbelt. Disgraceful, frankly. Those are not truly affordable homes.
	With these houses will come more traffic. Each one of these executive houses will have at least two cars. It is clear that 900 extra cars on roads that are already congested is going to impact on air quality. Notwithstanding the obvious inability of the existing roads to accommodate the extra traffic, this site flies in the face of PfE Objective 7 and this government's claimed objective of fighting climate change. Linked to this, we are living in unprecedented times. The site is used by residents to maintain their wellbeing, to play, to exercise to recharge, to escape. Adding 450 households into the mix will make this even worse with the resultant severe impact on already stretched local health and social services.
