The Places for Everyone (PfE) Plan uses allocation policy numbers that are different to those used in the Greater Manchester Spatial Framework (GMSF). The GMSF policy numbers (and in some instances the allocation names) were also different to the allocation references used by LUC in their original assessments. For consistency with those earlier assessment reports, the original LUC allocation codes are used in this addendum, but for ease of reference the table below sets out a comparison between the LUC Allocation references and names, the 2020 GMSF policy numbers and names, and the 2021 PfE policy numbers. The following map shows the allocation locations with their PfE Plan policy numbers.



Chapter 1

Introduction

Explanation of requirement for addenda to the GMSF 2020 evidence base

1.1 In November 2014, the AGMA Executive Board recommended to the 10 Greater Manchester local authorities that they agree to prepare a joint Development Plan Document (“Joint DPD”), called the Greater Manchester Spatial Framework (“GMSF”) and that AGMA be appointed by the 10 authorities to prepare the GMSF on their behalf.

1.2 The first draft of the GMSF DPD was published for consultation on 31st October 2016, ending on 16th January 2017. Following substantial re-drafting, a further consultation on the Revised Draft GMSF took place between January and March 2019.

1.3 On the 30 October 2020 the AGMA Executive Board unanimously agreed to recommend GMSF 2020 to the 10 Greater Manchester Councils for approval for consultation at their Executives/Cabinets, and approval for submission to the Secretary of State following the period for representations at their Council meetings.

1.4 At its Council meeting on 3 December Stockport Council resolved not to submit the GMSF 2020 following the consultation period and at its Cabinet meeting on 4 December, it resolved not to publish the GMSF 2020 for consultation.

1.5 As a joint DPD of the 10 Greater Manchester authorities, the GMSF 2020 required the approval of all 10 local authorities to proceed. The decisions of

Stockport Council/Cabinet therefore signalled the end of the GMSF as a joint plan of the 10.

1.6 Notwithstanding the decision of Stockport Council, the nine remaining districts considered that the rationale for the preparation of a Joint DPD remained. Consequently, at its meeting on the 11th December 2020, Members of the AGMA Executive Committee agreed in principle to producing a joint DPD of the nine remaining Greater Manchester (GM) districts. Subsequent to this meeting, each district formally approved the establishment of a Joint Committee for the preparation of a joint Development Plan Document of the nine districts.

1.7 Section 28 of the Planning and Compulsory Purchase Act 2004 and Regulation 32 of the Town and Country Planning (Local Planning) (England) Regulations 2012 enable a joint plan to continue to progress in the event of one of the local authorities withdrawing, provided that the plan has 'substantially the same effect' on the remaining authorities as the original joint plan. The joint plan of the nine GM districts has been prepared on this basis. Consequently, the Plan is proceeding directly to Publication stage under Regulation 19 of the Town and Country Planning (Local Planning) England Regulations 2012.

1.8 Its content has changed over time through the iterative process of plan making, but its purpose has not. The Stage 2 Greater Manchester Green Belt Study formed part of the evidence base which was assembled to support the policies and proposals in the GMSF 2020. Given the basis on which the PfE has been prepared, the GMSF evidence base remains valid in relation to the PfE 2021. That said the Stage 2 Greater Manchester Green Belt Study has been reviewed and updated in the light of the change from GMSF 2020 to the PfE 2021 and, where appropriate, addendum reports have been produced and should be read in conjunction with the Stage 2 Greater Manchester Green Belt Study documents made available in October 2020.

Previous components of the Stage 2 Greater Manchester Green Belt Study

1.9 A Green Belt study was undertaken, assessing the potential harm to the Green Belt that could result from release of land within the development allocations proposed in the Revised Draft (January 2019) of the Greater Manchester Spatial Framework (GMSF) [See reference 1]. Its intention was to inform the finalisation of the proposed Allocations.

1.10 In September 2020, an addendum to the assessment of allocations proposed in the 2019 GMSF was produced. Entitled 'Addendum: Assessment of Proposed 2020 GMSF Allocations', its purpose was to consider the impact, in terms of harm to the Green Belt purposes from the release of land, of a number of changes to the proposed Allocation boundaries and areas of Green Belt release identified in the updated 2020 version of the GMSF.

1.11 These assessments form part of Stage 2 of the Green Belt assessment process. Other elements of Stage 2, which are presented as separate reports, include:

- An assessment of the contribution to the Green Belt purposes that would be made by the addition of new Green Belt land proposed in the 2020 GMSF [See reference 2] .
- An assessment of the combined effect of proposed releases and proposed new Green Belt on the strategic functioning of the Greater Manchester Green Belt [See reference 3].
- An analysis of the potential to enhance the beneficial use of the remaining Green Belt in the vicinity of the proposed Allocations [See reference 4].

Content of this addendum


1.12 This report forms a second addendum to the assessment of allocations proposed in the 2019 GMSF. It considers the impact, in terms of harm to the Green Belt purposes from the release of land, of changes to the proposed Allocation boundaries and areas of Green Belt release identified in the 2021 PfE Plan. It should be read in conjunction with the reports and first addendum listed above, and also with addendums that have been prepared to reflect the impact of the PfE Plan changes on:

- The contribution to the Green Belt purposes that would be made by the additional Green Belt as proposed in the 2020 GMSF [\[See reference 5\]](#).
- The combined effect of proposed releases and proposed new Green Belt on the strategic functioning of the Greater Manchester Green Belt [\[See reference 6\]](#).

1.13 The allocations and Green Belt additions proposed within the 2021 PfE Plan are shown in Figures 1.1a (with the same allocation references as used in the 2019 and 2020 versions of the GMSF) and 1.1b (with the JPA Allocation references used in the PfE Plan).

1.14 Chapter 2 details the changes made to allocations, and assesses any impact on the 2019 and 2020 GMSF Green Belt harm analysis, and Chapter 3 provides a summary of the impact of the changes, with maps showing variations in harm rating to update those provided in the 'Addendum: Assessment of Proposed 2020 GMSF Allocations'.

2021 PfE Site Allocations and Proposed Green Belt (original allocation references)



Assessment of changes to potential harm of release

Introduction

2.1 This chapter considers each allocation where either boundaries, proposed Green Belt release or proposed creation of adjacent new Green Belt have changed from those presented in the 2020 GMSF. 14 of the 47 GMSF 2020 allocations, listed in Table 2.1 below, are affected.

2.2 GM Allocation 49 (North of Mosley Common) has not been amended since the 2020 GMSF, but it has been noted that a change in the allocation boundary between the 2019 and 2020 versions of the GMSF was not reported in the addendum produced in 2020. It is, therefore, included in the analysis below.

2.3 For each affected allocation within the PfE Plan area, the following are provided:

- A map of the changes, showing both the 2020 GMSF and 2021 PfE details for comparison.
- A description of the changes shown on the map.
- An analysis of the impact of the changes, identifying any resultant changes in harm from release of the allocations from that applicable to the 2020 GMSF (as reported in the harm assessment for the 2019 GMSF or the 2020 GMSF addendum).



- A table to indicate the changes in amount of land being released within the proposed allocations, and the associated levels of harm to the Green Belt purposes.
- A second map, showing the 2021 PfE boundaries along with shading to illustrate the assessed levels of harm that will result from the release.

2.4 With regard to the harm area tables noted above, there are minor mapping discrepancies between the 2020 GMSF and 2021 PfE Plan boundaries which mean that there is some minor variance in the calculations provided for sizes of areas being released at different harm levels.

2.5 Reference should be made to the assessment of the proposed 2019 GMSF allocations for an explanation of the methodology used to assess the harm of releasing Green Belt land within those allocations.



Description

The 2021 PfE Plan proposes the retention within the Green Belt of an area of land on the southern edge of the Allocation, the area closest to the settlements of Chadderton Fold and Healds Green.


Analysis

The release of any of the land to the south of Stakehill Distribution Park, area GM2-4, was previously assessed as causing high harm to the Green Belt purposes. The land here makes a strong contribution to Green Belt Purpose 1 (checking the sprawl of a large built-up area) and Purpose 3 (safeguarding the countryside from encroachment), with Boarshaw Lane and a tree belt along the edge of the Distribution Park forming a fairly strong boundary to the rising land to the south-east. The retention of a slightly broader belt of land between Stakehill and Chadderton Fold will help to retain distinction between the two urban areas, but the revised release would still constitute a minor impact on the adjacent Green Belt, through containment of remaining land in the settlement gap, so the harm rating is still high.



Description

The 2021 PfE Plan Allocation boundary has been revised very slightly in order to exclude a small field and hedgerow on the south-eastern edge of the Allocation, adjacent to The Elton High School (an area of approximately 0.4ha).

Analysis

The area affected by the original Allocation boundary was too small to assess as a distinct area, given the strategic nature of the assessment. It's exclusion from the GM9 Allocation therefore has no bearing on the harm assessment findings. Harm of release of the Allocation is, therefore, still moderate.




The land now proposed for retention in the Green Belt lies within an area that was added in the 2020 GMSF to the original 2019 GMSF Allocation. The addendum which assessed the proposed 2020 GMSF Allocations assigned a high harm rating to all of the land west of the former Wood Park Colliery (GM13-3), citing a strong contribution to Green Belt Purpose 1 (checking the sprawl of a large built-up area) and Purpose 3 (safeguarding the countryside from encroachment). The revised Green Belt boundary, formed by field edges, was judged to be weaker than the wooded edge of the former colliery.

Although the farm track that forms the edge of the amended Allocation can be considered a marginally stronger boundary than the poorly defined field edges to the west, it is nonetheless still a weaker boundary than the wooded edge of the colliery site. The land in GM13-3 still makes a strong contribution to Purposes 1 and 3, so the harm of release of this part of the allocation is still high. The harm of releasing the former colliery, GM13-1, is still moderate-high.







Analysis

The harm of releasing the 2019 Allocation was assessed as being moderate. This was chiefly associated with the loss of contribution to Green Belt Purpose 3 (safeguarding the countryside from encroachment) that would have resulted from the release of open countryside in between the mill buildings and the edge of Greenfield. Impact on the remaining Green Belt was considered to be negligible, given the degree of constraint associated with the proximity of the Peak District National Park to the south and east of the site, and with the wooded valley side forming a strong boundary to the north. Much of the area now proposed for release is occupied by built development that diminishes Green Belt openness, and the remainder of the site, although it contains some tree cover and some storage areas (including a former water body), is significantly influenced by that built development. The revised Allocation therefore makes only a relatively limited contribution to Purpose 3, and its degree of separation from the urban edge, relative to its size, together the extent of development on the site, means that it does not contribute to preventing the sprawl of the large built-up area of Greater Manchester. There is no change to the 2019 ratings for contribution to other Green Belt purposes. However, whereas the impact on adjacent Green Belt of the proposed 2019 release was considered to be negligible, the now-retained Green Belt land between the Allocation and the edge of Greenfield would be subject to a slightly greater degree of urbanising containment, which would constitute a minor impact on its strength. The release of the revised GM18 Allocation would therefore cause low-moderate harm to the Green Belt purposes.





The slight expansion of the Allocation out to the new road makes little difference to the area of land released, and creates a logical Green Belt boundary following a defined physical feature. The area of woodland affected by the original Allocation boundary was too small to assess as a distinct area, given the strategic nature of the assessment. Its exclusion from the GM31 Allocation therefore has no bearing on the harm assessment findings. Harm of release of sub-area GM31-2 within the Allocation is, therefore, still moderate.




Analysis

Although it constitutes a significant reduction in the size of the Allocation, the retention of the northernmost field does not alter the moderate harm rating given to the original 2019 GMSF Allocation, and to the slightly reduced 2020 GMSF Allocation. The field that will be retained in the Green Belt does not make a significantly stronger contribution to the Green Belt purposes than other land in the Allocation, and its release or retention does not significantly alter the impact of the Allocation on the adjacent Green Belt, which was assessed as negligible. The new boundary will for the most part be defined by a hedgerow, whereas the field that was formerly to be released is bordered only by a shallow ditch and several trees; neither constitutes a strong boundary, but the existing inset settlement edge to the east is also weakly defined.
