**PURPOSE OF REPORT**

- i. To inform Members of recent and planned changes to the bus network in July, August and September 2018, in addition to report on consequential action taken or proposed by Transport for Greater Manchester; and
- ii. To seek guidance from Members on proposed Transport for Greater Manchester action.

## 1. Background and Introduction

- 1.1 Members of Transport for Greater Manchester Committee are asked to consider the bus service changes proposed in this report to ensure continuity of bus service provision to passengers and the provision of associated customer information by TfGM in relation to the proposed bus service changes.
- 1.2 The changes proposed to be effective in July include those that require approval for TfGM to provide subsidised services following the de-registration of bus services by commercial bus operators.
- 1.3 Changes are planned to be effective from either the 22, 23 or 30 July 2018 and require approval in order for customer information to be updated and for operational preparations to be made by bus operators.
- 1.4 One change in response to a commercial service de-registration is also proposed to be effective from 31 August 2018; and three changes proposed require approval for TfGM to make frequency changes to subsidised services, effective from early September 2018.
- 1.5 The proposed bus service changes planned to become effective during August and September require approval in order for statutory notice period requirements to be met.
- 1.6 Transport for Greater Manchester officers ensure that the cost of the subsidised services is kept within the appropriate budget or any cash limits. This is achieved through:-
- rationalisation of existing services whilst maintaining key links on the network;
  - engaging with operators with the objective of them taking on “marginal commercial” services; and
  - continuing to redesign and restructure grouped services to ensure that maximum value is obtained from subsidy.
- 1.7 In general, withdrawals, reductions or amendments to services are currently only planned at the date of next renewal of the contract concerned.
- 1.8 The governance process that leads up to the reporting to Members involves the scrutiny of all tendered services at TfGM’s Tender Panel that consists of representatives from Legal, Procurement and Finance as well as the Bus Services Function.
