# EYFS online service – 'Help for early years providers'

#### Introduction

From September 2021, all early years providers must follow the new <u>early years foundation stage</u> (<u>EYFS</u>) <u>framework</u>. To ensure practitioners supporting early years children have the information and support they need to implement the changes consistently, a **new online service** is being launched.

## EYFS online service – 'Help for early years providers'

- From September 2021, all early years providers must follow the new <u>early years foundation stage</u> (EYFS) framework.
- The key aims of the reforms are to:
  - improve child outcomes at age 5, particularly in early language and literacy, especially for disadvantaged children; and
  - reduce workload, such as unnecessary paperwork, so that practitioners can spend more time interacting with children in their care.
- 85% of the early years workforce are made up of practitioners working with children aged 0-4 in the PVI sector.
- The new online service is being launched to ensure childminders, nursery leaders and pre-school
  practitioners have the information and support they need to implement the changes consistently.
- Developed with sector experts and extensively tested with PVI staff and childminders, the
  service features information and resources to support the workforce to implement the reforms
  effectively. This includes details of what the changes mean in practice as well as ideas for activities.



## EYFS online service – 'Help for early years providers' cont.

#### **Useful information**

- The website covers all 7 areas of learning from the EYFS framework. Each of these has been broken down into 3 sub-categories (based on the educational programmes) so that we can provide bite-sized information for each part of the educational programme. Overarching resources (those within the 'improve your practice') section were decided upon based on the needs identified as part of user research.
- We have worked with sector experts to develop the resources. We have also shared the resources
  with a range of key stakeholders for comment and have taken on board their feedback.
- The online service is currently in 'public beta' phase this means that it is in a testing phase of development and is, therefore, subject to change following user feedback.
- **Further content**, including additional videos, is planned to be added to the website over time. Additional content will be decided based on user feedback of their needs.

## Communications – Email text to use

The suggested email text below has been drafted to support stakeholders in publicising the online service and help get the message to childminders and staff in PVI settings.

From September 2021, all early years providers must follow the new <u>early years foundation stage (EYFS) framework</u>.

The **key aims** of the reforms are to:

- improve child outcomes at age 5, particularly in early language and literacy, especially for disadvantaged children; and
- reduce workload, such as unnecessary paperwork, so that practitioners can spend more time interacting with the children in their care.

To support the implementation of the revised EYFS, the Department for Education has developed a new **online service** for private, voluntary and independent early years settings and childminders. This service provides resources, advice and support to help practitioners to understand the requirements for each area of learning and development and what these requirements mean in practice.
