### The background of this work...

- Launched the 'Greater Manchester Falls Prevention: Delivering Integration and Reconditioning' Report (January 2022)
- Commitment to develop a 'Greater Manchester Falls
   Collaborative' to deliver on the 6 key recommendations detailed in the report.
- Pulled together a 'Greater Manchester Falls Collaborative Strategy group' to provide strategic leadership and guidance to the development of this work across the system.
- Consulted with key falls prevention leads across the system (all 10 localities) at the January event and started to populate the key *'opportunities for action'* consequently pulling together a DRAFT 'Greater Manchester Falls Collaborative Action Plan' for the system.

## **The Greater Manchester Falls Collaborative**

- The GM Falls Collaborative has been established to oversee and deliver the strategic and operational system level priorities and recommendations for falls prevention, integration and reconditioning across community, clinical and care settings.
- The collaborative will send a clear message that falls prevention is a continued priority, in enabling improved health outcomes for all, working towards co-created integrated pathways, raising the profile of what works in terms of life course approaches, prevention and evidence-based interventions.

#### **GM Falls Collaborative:**

Improving the health and wellbeing of GM residents in preventing falls, improving strength and balance and supporting reconditioning.

- Establishing clear governance and membership to broaden integration, reach and impact of specific and wider strategic programme priorities
- Championing implementation of evidence-based programmes
- Developing a Theory of Change for integrated action based on priority areas identified
- Ensuring and facilitating linkages and support within the GMHSCP/ICS to support the enablement of falls prevention programming and investment across the GM system
- Changing the narrative through a proactive shift towards positive age- inclusive language, practice and gain framing to reduce stigma and overcome ageism



Workforce development, recruitment and training	<ul> <li>Developing workforce capacity jointly across GM through appropriate level qualifications and progression through to higher levels.</li> <li>Recruitment targets for a representative workforce (age, ethnicity, sexuality, gender) to enable true equity of access to provision and to reduce barriers</li> <li>Cross-work shadowing and development opportunities to enhance skills and build relationships across providers</li> </ul>
Digital technologies that enhance	<ul> <li>Scaling innovation and technologies that are developed using human- centred design, co-created and evidence-based</li> <li>Identification and 'test-bedding' blended models of intervention, building on what was grown during pandemic</li> </ul>

### A 'Community of learning, sharing and problem solving' What's the purpose?

- To bring together a collective with a **shared purpose**.
- To develop a mechanism for effective sharing, including workshops, action learning sets, updates, conferences, etc
- **Diverse and unrestricted membership** to enable collaboration to feed into and across priority areas.
- Showcasing and celebrating what works effectively across Greater Manchester within communities and neighbourhoods.

#### **Awareness Raising**

-Annual conference for 'Falls Prevention' to bring together the system on this collective journey (Could be used to review the action plan as a whole-system?) -Monthly webinars on key topics from E&T -TV advertisements for Falls Prevention (similar to the approach to strokes) -Leaflet for GM on Falls Prevention

#### **Education & Training**

-Risk factors for falls -Bone Health Information -Frailty -Falls Prehabilitation (Later Life Training) -CPD Opportunities -Other established programmes (PreHab4Cancer)

#### Digital

-Showcasing assistive technologies and healthcare

-The 'Keep On Keep Up' (KOKU) application -Tech solutions to bringing the system together around falls prevention (Webpage, MS Teams channel etc).
